The meeting was called to order by Mayor Weatherwax

A motion was made by Brent White to dispense of the reading of January 23, 2017 minutes and to approve them. The motion was second by Joyce Jeffreys, with all voting in favor.

With Jackie Burch not present for the second item on the agenda concerning dirt work at park this item was tabled until the next meeting with all voting in favor.

Damon Morgan will work in conjunction with council to make revisions to the ordinance.
