Mayor Weatherwax gave notice of the upcoming election which will be on Tuesday, August 25, 2020 for the purpose of electing a Mayor at large and Councilmember for each single District. Qualifying begins on Tuesday, July 7, 2020 at 8:00 AM and ends Tuesday, July 21, 2020 at 5:00 PM. Candidates may qualify at Moulton City Hall – 720 Seminary Street, Monday – Friday 8:00 AM – 12:00 PM and 1:30 PM – 5:00 PM.

Resolution 2020-012 was introduced to provide Tier I benefits to Tier II employees under the provisions of Alabama ACT 2019-132. This had been presented to Council at previous Work Session and talked about before when this first became an option. Council agreed that this would be a benefit to retain good employees for the future of the City of Moulton.
