Beginning October 1, 2020, Wholesale water will increase to \$1.90 per 1,000 gals after the first 5 million. Also, we will be increasing the cost of Utilities by 1% more and including gas in this yearly increase at 4% - in the past Gas was not included in the yearly increase. Also, the gas department has not been requiring Tapping Fees like the Water Department as of Oct 1, 2020 Tapping Fees will be required. (see attached rates and charges). Under the recommendations from the Supervisors and Mayor

Weatherwax on these changes it was ask that immediate action be taken to have this in place for the October 1 billing.
