Meeting was called to order by Mayor Weatherwax followed by pledge and prayer.

The minutes for November 15, 2021 Council Meeting and November 22, 2021 Work Session the Mayor ask to be approved and dispensed of the reading of.

Craig Knight Police Chief had a few request and information for the Council.

Chief Knight ask:

- 1) Council approve for him to attend the Chief's Conference February 27, 2022 – March 3, 2022

- 2) Approve to move forward with the purchase Police Patrol vehicle that was in Budget in the amount of \$24,334.27 and that they were salvaging the equipment from the previously wrecked vehicle will be used on this vehicle to save those cost.

Jason White along with other Council ask that the American Rescue Money be looked at to see if this purchase could be made with that money. If the Rescue Money can be used the funds to pay for this vehicle would come from that if not it would come out of the Police Budget.

- 3) Chief Knight wanted to make Council aware that the shooting range owned by the City of Trinity is now implementing a \$200.00 yearly fee for the department to use the facility. The fee would include targets, stands, and up keep for the facility.

Mark Heflin was on agenda to ask for approval to purchase piping needed for the Park Project (Mr. Heflin wasn't present at this time) Mayor Weatherwax moved forward with the request and Council members elected to approve the purchase.

Emily Edwards – accountant was present to ask Council to consider options for Premium Pay through the American Rescue Funds Monies.

Council was presented with options for Resolution 2021-0011

- 1) \$2,000.00 for Full time and \$1,000.00 for Part time,
- 2) \$2,000.00 for Full time and \$500.00 for Part time,
- 3) \$2,000.00 for Full time only.

Motion was made by Denise Lovett for \$2,000.00 Full time and \$1,000.00 Part time.

All members of Council voted in agreement with this motion. Following Federal guidelines only employees – employed as of this date December 6, 2021 will be eligible to receive this benefit.

Ms. Cassandra Lee had ask for there to be changes made to when agenda’s would be available so Council would have time to prepare for meetings. Ordinance 2016-005 was currently on record so Ordinance 2021-004A was presented with the change being to section 6 which now will be stated as: **Section 6. Council Meeting agendas will be prepared the Friday prior to the Council meeting. Any person, organization or council member requesting to be placed on the agenda must submit their request no later than 12:00 PM Friday prior to the Council Meeting. The exception would be any administrative or emergency items that require immediate attention approve by the Mayor.**

Motion to adopt Ordinance 2016-005 amending Ordinance 2021-004A Section 6: Cassandra Lee

Ms. Cassandra Lee spoke to the Council and made the request that meetings of the Council be recorded. There was discussion among the Council as to who would do this and the responsibility of keeping said recordings. Ms. Lee said it would be the City Clerks job to do so. Ms. Jeffreys stated she didn’t see a problem with doing the recordings.
